The short-term consolidation phase

VN30 performance

The VN30 index formed the closing price at 1,532 pts. Relating to foreign trading activities, selling activity came back with net sell value recorded at VND60bn. Notably, foreign supply spread to HPG, VIC, and NVL.

VN30 Future chart: Balance stage

Volatility is increasing on VN30F2202, but the bullish momentum has been improved. Bullish signals is still unclear when major MAs keep staying on the fence. However, the instrument closed above major MAs, implying the improvement of bullish momentum. With congestion zone, 1,470 pts zone acts as the important support whilst 1,540 pts area will be the last barrier for the upward resumption phase.

Technical strategy

Long VN30F2202 should be held and stop the loss when there is the closing price below 1460 pts level (Hourly chart).



Figure 1. VN30 Generics hourly chart





Figure 2. Basis spread





Figure 4. Open interest pattern




