Market is on the fence

VN30 performance

The VN30 index formed the closing price at 1,426 pts. Relating to foreign trading activities, selling activity ticked up with net sell value recorded at VND40bn. Notably, foreign supply spread to SSI, NVL, and HPG.

VN30 Future chart: All eyes on 1,500 pts zone

VN30F2203 keeps experiencing the volatile period and major indicators are still on the fence. With congestion zone, 1,450 pts zone and 1,550 pts zone are the range demand and supply area (Daily chart). As major MAs are flat on Daily chart with narrow Bollinger bands, consolidation phase could be extended. For intraday movement, 1,500 is the benchmark. In this case, traders should hold the long positions and avoid intraday trading due to the increase of volatility level.

Technical strategy

Long position on VN30F2203 should be held and stop the loss when there is the closing price below 1,500 pts level (Hourly chart).



Figure 1. VN30 Generics hourly chart





Figure 2. Basis spread





Figure 4. Open interest pattern




