# The benchmark is broken

## **VN30** performance

The VN30 index formed the closing price at 1,440 pts. Relating to foreign trading activities, supply ticked up with net sell value recorded at VND380bn. Notably, foreign supply spread to HPG, BVH, and CTG.

### VN30 Future chart: Major MAs are broken

VN30F2204 kept experiencing the selling activity, piercing the 1,470 pts zone which is the trading range's lower threshold and confirming the downtrend. Particularly, major MAs were broken, bearish momentum has completely controlled. The upcoming demand zone is expected to place around 1,420 pts area. However, selling pressure has reached the extreme which means rebound phase is needed. In this case, traders should stay on the sidelines and wait for the new short positions which would come after the rebound phase.



Figure 1. VN30 Generics hourly chart





Figure 2. Basis spread





Figure 4. Open interest pattern




