Market commentary

Intraday rebound

The stock market was divergent yesterday. However, the high demand at low prices made the indices recover.

At the close, the VNIndex gained 0.07% to close at 1,241 pts. Meanwhile, the trading volume was 471 million shares or VND12,783bn.

Foreign investors reversed to net sell with a net value of VND125bn on HSX. They sold HPG, SSI, and VIC the most, with net values of VND134bn, VND80bn, and VND46bn, respectively.

Energy was the market leader driven by BSR (+5.07%), GAS (+0.76%), OIL (+1.48%), POW (+1.19%), PVC (+7.48%), PVD (+6.90%), PVS (+5.20%), and PVT (+3.45%).

Brokerage outperformed the benchmark index, namely BVS (+6.44%), HCM (+1.97%), VCI (+5.07%), and VND (+1.82%).

Some constituents of the VN30Index jumped more than 1% driven by MSN (+6.98%) and HDB (+1.25%).

In contrast, selling pressure Banking and Real Estate down due to BID (-0.72%), CTG (-1.88%), TCB (-0.69%), VPB (-1.62%), DXG (-4.49%), NVL (-0.38%), and VIC (-0.13%).

Despite the bullish market in the short term, the liquidity is still low level, implying the bullish trend is not confirmed. Therefore, traders should wait for the next signals and stay on the sidelines.
