Market commentary

Short-term profit-taking

The stock market was divergent yesterday although some macro indicators showed positive signals in May.

At the close, the VNIndex closed almost unchanged at 1,218 pts. Meanwhile, trading volume was 528 million shares/VND11,821bn, down 1% / 8% respectively, from the previous week's average.

Foreign investors reversed to net sell with a net value of VND189bn on HSX. They sold HPG, DCM, and VCB the most, with net values of VND77bn, VND69bn, and VND63bn, respectively.

Cash flowed into Banking and Brokerage, namely BID (+3.71%), CTG (+0.56%), HDB (+0.62%), STB (+0.22%), TCB (+0.14%), HCM (+1.88%), and SSI (+0.77%).

Some constituents of the VN30Index jumped more than 1% such as VNM (+2.12%) and HPG (+1.11%).

In contrast, selling pressure Energy down BSR (-3.69%), OIL (-2.29%), PLX (-1.91%), POW (-1.08%), PVD (-1.69%), and PVS (-1.57%).

Market sentiment has become cautious due to profit-taking. Therefore, traders should stay on the sidelines and wait for the next signal. Besides, traders should watch the double bottom pattern as the levels of the two last bottoms are the same.

The Vietnam Securities Depository (VSD) has announced a Draft Regulation on clearing and settlement of securities transactions for comments. Accordingly, investors can receive cash and securities earlier at 12 o'clock on T+2, instead of 4PM T+2.

To implement this change, the exchange process between VSD, NHTT and related member securities companies will also be adjusted and shortened.
