The VN30 index formed the closing price at 1,252 pts. Relating to foreign trading, selling activity ticked up with net sell value recorded at VND330bn. Notably, foreign supply spread to VPB, VCB, and VIC.

VN30 Future chart: The demand zone is still held

VN30F2207 retested 1,220 pts zone on the previous trading day and this zone continued to be respected. The unbroken 1,200 pts area confirms the market short-term bottom. However, the major MAs are pierced on Daily chart, the major swing is still bearish. If the 1,220 pts area is broken, the long signal would be invalid. In this case, traders should continue to hold the opened long positions.



Figure 1. VN30 Generics hourly chart






Figure 2. Basis spread

Figure 4. Open interest pattern




