# **Demand is still weak**

# **VN30 performance**

The VN30 index formed the closing price at 1,242 pts. Relating to foreign trading, selling activity ticked up with net sell value recorded at VND75bn. Notably, foreign supply spread to MWG, HPG, and NVL.

# VN30 Future chart: The demand zone is still held

VN30F2207 decreased slightly on the previous trading day due to the maintenance of selling pressure near 1,250 pts zone. The unbroken 1,200 pts area confirms the market short-term bottom. However, the major MAs are pierced on Daily chart, the major swing is still bearish. If the 1,220 pts area is broken, the long signal would be invalid. In this case, traders should continue to hold the opened long positions.

# **Technical strategy**

Long position on VN30F2207 near 1,240 pts area should be held and stop the loss when there is the closing price below 1,220 pts level. (Hourly chart)



Figure 1. VN30 Generics hourly chart






Figure 2. Basis spread

#### Figure 4. Open interest pattern




