Bearish pattern is formed

VN30 performance

The VN30 index formed the closing price at 1,209 pts. Relating to foreign trading, buying activity came back with net buy value recorded at VND75bn. Notably, foreign demand spread to VNM, PNJ, and MWG.

VN30 Future chart: Selling pressure still exists

VN30F2207 retested 1,200 pts area, completely forming the bearish pattern (lower high and lower low). As the previous trough is pierced, the bearish swing has high probability to extend. The major MAs are pierced on Daily chart, the major swing is still bearish. Notably, the bearish swing could extend on this trading day due to the increase in OI. In this case, traders should hold the captured short position.

Technical strategy

Short position on VN30F2207 near 1,230 pts zone should be held and stop the loss when there is the closing price above 1,240 pts level. (Hourly chart)



Figure 1. VN30 Generics hourly chart



Figure 2. Basis spread





Figure 4. Open interest pattern




