Position size should be minimized

VN30 performance

The VN30 index formed the closing price at 1,231 pts. Relating to foreign trading, buying activity surged with net buy value recorded at VND130bn. Notably, foreign demand spread to SSI, VHM, and VIC.

VN30 Future chart: Selling pressure still exists

VN30F2207 attracted demand near 1,200 pts area, but the selling pressure still exists. As the benchmark for the rebound phase (1,220 pts area) is violated, the rebound phase is invalid. The major MAs are pierced on Daily chart, the major swing is still bearish. The bearish swing has high probability to extend on this trading day due to the formed lower higher and lower low pattern. However, volatile trading environment has occurred as well as OI continued to fall which means volatility level could remain on this trading day. In this case, traders should hold the captured short position.

Technical strategy

Short VN30F2207 near 1,230 pts zone and stop the loss when there is the closing price above 1,240 pts level. As the volatile trading environment still exists, position size should be minimized. (Hourly chart)



Figure 1. VN30 Generics hourly chart





Figure 2. Basis spread





Figure 4. Open interest pattern




