Approaching the solid selling zone

VN30 performance

The VN30 index formed the closing price at 1,295 pts. Relating to foreign trading, foreign investors resumed to net buy with a net value of VND112bn on VN30. Demand was mainly spread to HPG, HDB, and CTG.

VN30 Future chart: Approaching the solid selling zone

VN30F2208 retested 1,300 pts zone and bullish momentum has shown no sign of weakness. However, minor pullback is needed in order to strengthen the rebound phase. Notably, 1,250 pts area is the benchmark for the rebound phase. If this zone is broken, rebound phase is faded. On Daily chart, major MAs confirm the bear market rally and there is the tendency for this instrument to head to 1,350 pts zone. OI (Open Interest) has started to drop on VN30F2208 but total OI remains at high level, implying the active rebound phase on the upcoming contract. Besides, VN30F2208 is traded 5 pts above VN30F2209 which means the market is in backwardation mode as well as there is the probability for the instrument to enter intraday correction. In this case, traders should hold the captured long positions.

Technical strategy

Long position on VN30F2208 near 1,220-1,225 pts area should be held and close the positions when there is the closing price below 1,250 pts level. (Hourly chart)



Figure 1. VN30 Generics hourly chart





Figure 2. Basis spread





Figure 4. Open interest pattern




