Bullish momentum is temporary paused

VN30 performance

The VN30 index formed the closing price at 1,295 pts. Relating to foreign trading, foreign investors reversed to net sell with a net value of VND102bn on HSX.

VN30 Future chart: Approaching the solid selling zone

VN30F2209 approached the solid selling zone and selling pressure has started to increase. The bullish momentum is temporary paused due to the broken short-term MAs. Notably, 1,250 pts area is the benchmark for the rebound phase. If this zone is broken, rebound phase is faded. On Daily chart, major MAs confirm the bear market rally. OI (Open Interest) has started to increased which means the market swing is still active. However, VN30F2209 is traded 14 pts below VN30 Index which means volatile environment could occur. In this case, traders should stay on the sidelines and wait for accurate trading point.

Technical strategy

VN30F2208 is expired and the upcoming contract (VN30F2209) has shown no valid trading signal. In this case, traders should stay on the sidelines and wait for accurate trading point.



Figure 1. VN30 Generics hourly chart



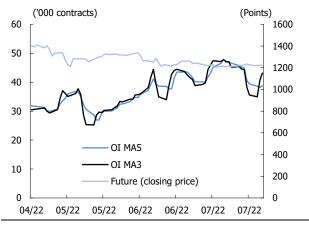

Figure 2. Basis spread





Figure 4. Open interest pattern




