VN30 performance

The VN30 index formed the closing price at 1,261 pts. Relating to foreign trading, foreign investors' demand is active with a net buy value of VND40bn. They bought HPG, VRE, and HDB the most.

VN30 Future chart: Retesting 1,250 pts area

VN30F2209 experienced the selling pressure near 1,280 pts zone, forming subsequent lower high and increasing the tendency to retest 1,250 pts level. However, the range bound movement (1,250 - 1,300 pts area) is still respected. 1,250 pts area is the benchmark for the rebound phase. If this zone is broken, lower low would be completely formed and the rebound phase is totally faded. On the upside, the breakout at 1,300 pts zone would push the instrument to the next destination (1,350 pts area). OI (Open Interest) decreased strongly on VN30F2209, market swing is inactive. However, the upcoming contract (VN30F2210) keeps showing the increasing in OI which implies the active market swing on this contract. Notably, VN30F2209 is traded 7 pts above VN30F2210, market is on backwardation mode and volatility level could increase strongly on this trading date. As the range movement always carries whipsaws, traders should wait for breakout/breakdown to be confirmed before triggering the trade.

Technical strategy

VN30F2209 would be expired on this trading date. Thus, traders should stay on the sidelines and wait for the trading point on upcoming contract.



Figure 1. VN30 Generics hourly chart






Figure 2. Basis spread

Figure 4. Open interest pattern




