### Market commentary

#### Bottom fishing at 1,100-pts threshold

The stock market reversed to go up last Friday thanks to high demand at 1,100-pts threshold.

At the close, the VNIndex gained 0.54% to close at 1,132 pts.

Energy was the market leader thanks to GAS (+4.76%), NT2 (+3.27%), PVB (+6.17%), PVD (+5.32%), PVS (+3.11%), and PVT (+2.62%).

Brokerage and Banking outperformed the benchmark index driven by ACB (+0.91%), BID (+1.19%), CTG (+2.65%), MBB (+1.01%), STB (+4.57%), TPB (+1.21%), SSI (+2.59%), VCI (+2.08%), and VDS (+2.27%).

Some constituents of the VN30Index jumped more than 1% such as FPT (+4.55%), VRE (+2.94%), and SAB (+1.20%).

In contrast, PLX (-4.22%), KDH (-3.11%), HPG (-2.08%), and POW (-1.59%) closed in green territory.

Although the recovery, the downtrend is confirmed due to low liquidity. Therefore, traders should reduce long positions and wait for the next signals.

The medium-term downtrend is confirmed as the VNIndex closed below the significant moving average such as MA50 and MA100. Besides, the Index shows a new low. That implies a bearish market.

In the short term, the index moves in the downtrend channel with high selling pressure at the high level. In addition, the volume is still intact low, showing the cautious market sentiment. Therefore, any recovery in the last week may be a bull trap.

The 1,200-pts area is strong resistance. In addition, the 1,100 zone shows significant support.

=> The bearish trend is dominant in the short and medium term because of pessimistic sentiment.

#### ► Technical strategy: Wait for next signals

In this case, investors should reduce long positions and wait for the next signals.
