### Sell-off?

The stock market tumbled yesterday due to pessimistic sentiment after the CDS spread decreased.

At the close, the VNIndex lost 4.03% to close at 1,086 pts. Meanwhile, trading volume was 519 million shares/VND11,513bn, down 31%/ 15% respectively, from the previous week's average.

Foreign investors continued to net sell with a net value of VND532bn on HSX. They sold HPG, STB, and DGC the most, with net values of VND178bn, VND60bn, and VND46bn, respectively.

Banking was the worst sector driven by ACB (-2.70%), HDB (-3.92%), MBB (-6.50%), MSB (-3.32%), OCB (-6.21%), TPB (-4.60%), VCB (-3.55%), and VPB (-5.56%). Notably, BID, CTG, STB and TCB were down by the daily limit.

Selling pressure pushed Brokerage and Energy down, namely BSR (-4.04%), NT2 (-6.85%), POW (-6.88%), PVD (-6.82%), PVS (-7.76%), PVT (-6.89%), SSI (-6.82%), HCM (-6.94%), and VND (-6.86%).

Some constituents of the VN30Index slid more than 5% such as KDH (-6.95%), GVR (-6.94%), BVH (-6.92%), MWG (-6.88%), HPG (-6.84%), and VRE (-6.79%).

The VNIndex crosses down the 1,100-pts threshold, implying a downtrend. Besides, the market sentiment has become pessimistic. Therefore, traders should reduce long positions and wait for the next signals.
