Selling pressure ticks up

VN30 performance

The VN30 index formed the closing price at 1,008 pts. To be specific, BID (-4.5%), SSI (-3.0%), GVR (-2.8%), STB (-2.4%), and SAB (-2.0%) dragged the benchmark down. Relating to foreign trading activity, supply came back to high level with net sell value was VND85bn, mainly driven by large sell orders on NVL, VPB, and PDR.

VN30 Future chart: Bearish swing takes place

Bearish swing came back on VN30F2301 which has shown no sign of demand near 1,000 pts zone. Although there is the intraday rebound, demand is still weak. The 1,000 pts area is broken which means 900 pts zone would be the next destination. The rebound phase is totally faded due to the broken 1,000 pts zone. The instrument has confirmed the bearish swing and intraday pullback should be used to open new short positions. Notably, total OI (Open interest) came back to above 50,000 contracts, implying the high probability for the bearish swing to continue. In this case, traders could stay on the sidelines and wait for the intraday rebound to capture the short position.

Technical strategy

Short VN30F2301 near 1,000 pts zone and stop the loss when there is the closing price above 1,030 pts level. (Hourly chart)



Figure 1. VN30 Generics hourly chart





Figure 2. Basis spread





Figure 4. Open interest pattern




