

Inflow stays at low level

Vietnam foreign flow

Foreign demand came back, supply remained at 3-week average (USD230mn) and pushing the market to end up to be net bought. Net buy value was USD42mn.

Particularly, foreign demand was mainly absorbed by Financials and Materials, focusing on SSI, HDB, CTG, HSG, and HPG. Besides, Utilities also attracted solid buying activity, thanks to POW and GAS. On the contrary, foreign selling activity continued to focus on Real Estate (NVL, DXG, and KBC). IT became the most divested sector due to large sell orders on DGW.

South East Asia ETF flow

Last week, strong divestment remained across SEA, net outflow was USD37mn. Particularly, the strong outflow was mainly driven by the strong divestment across Indonesia (USD13mn) and Singapore (USD29mn). However, inflow has come back to Vietnam, partially faded the outflow in this region.

The inflow come back across Vietnam, but demand is still weak. Inflow was USD5mn. Inflow was still active across foreign ETFs such as FTSE Vietnam and VanEck Vietnam as well as there was no remarkable outflow across Fubon ETF. Notably, major ETFs which attracted the inflow during the last 6 months has started to be divested or experience the slowdown in inflow, such as VFMVN Diamond, VNFin Lead, VFMVN30 ETF, and KIM Growth VN30 ETF. In this case, there is still not a good sign for the stable inflow.

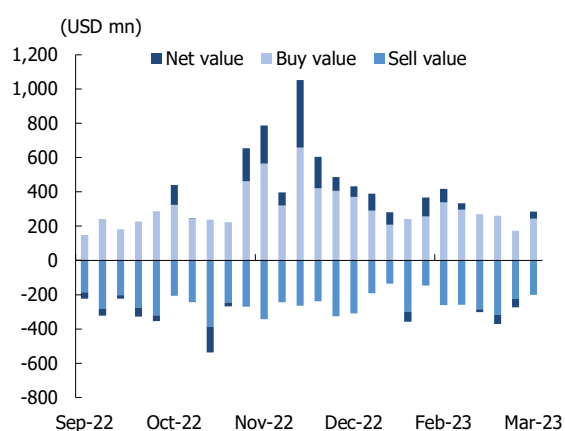

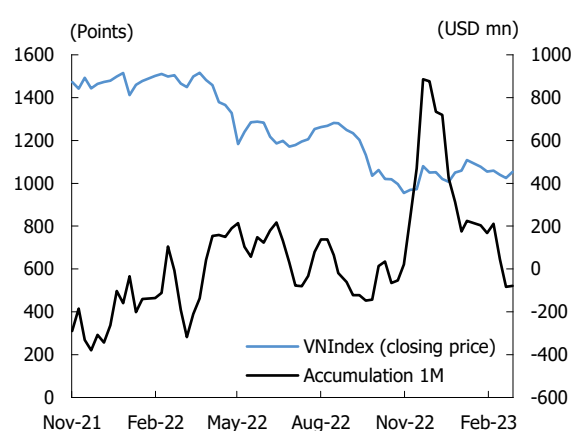

Figure 1. Weekly net foreign buy/sell



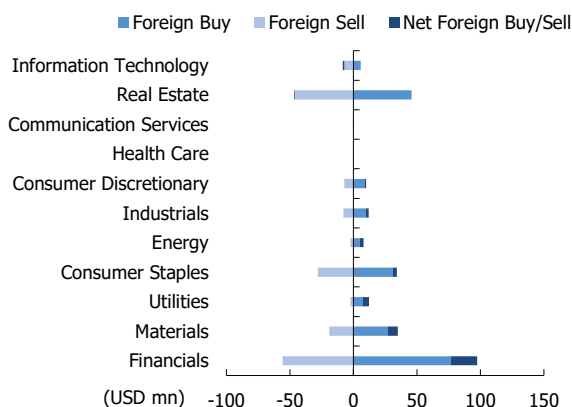

Figure 2. VNIndex and 1M accumulative foreign flow



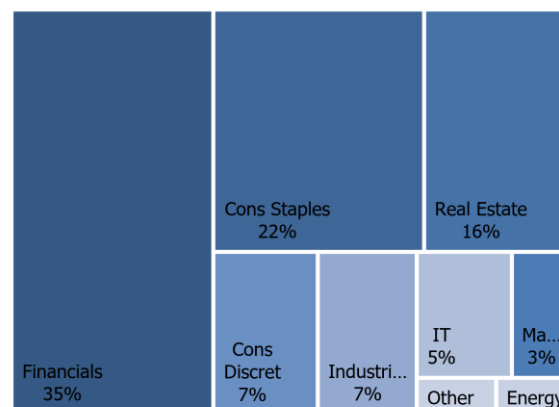

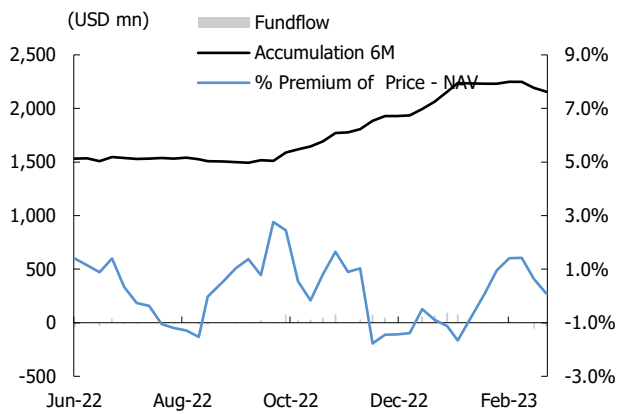

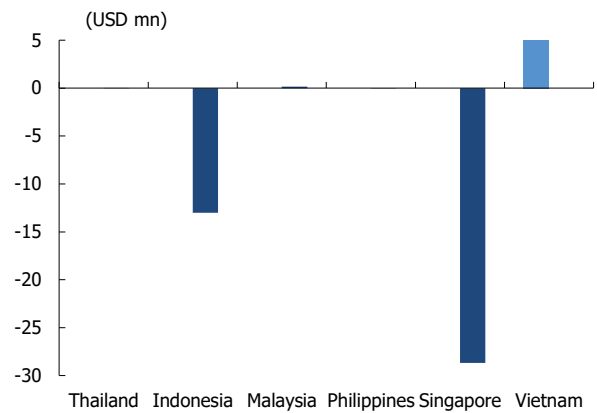

Figure 5. Weekly ETF net flow to SEA



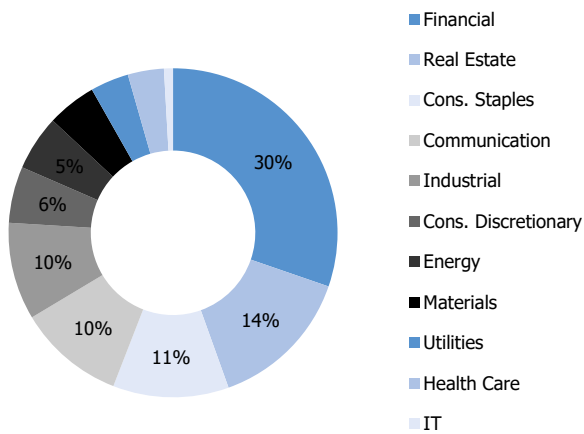

Figure 6. ETF net flow by country



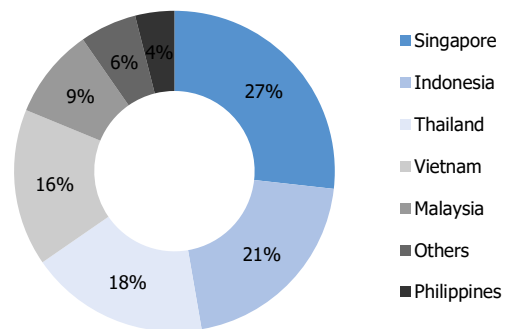

Figure 7. ETF focus by sector



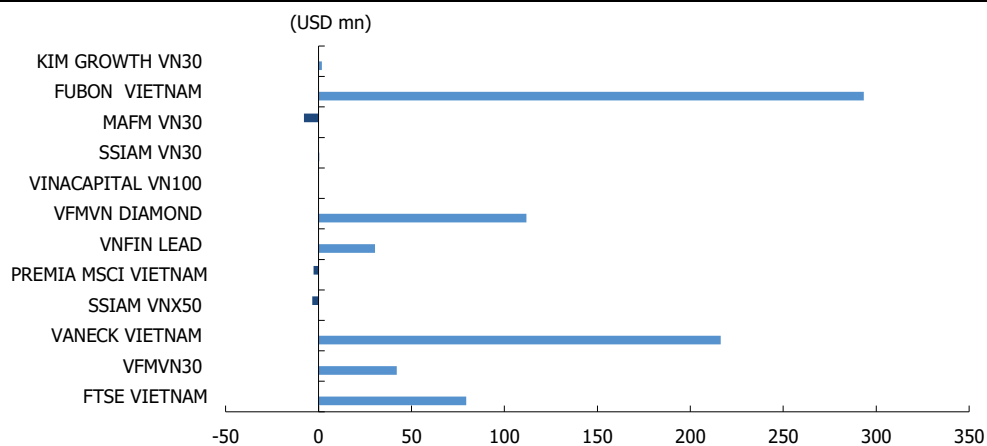
