

Fubon FTSE is the main driver for the surge of inflow

Vietnam foreign flow

Foreign demand continued to outweigh supply. Net buy value was USD17mn.

Particularly, foreign demand kept focusing on Real Estate and Materials sector thanks to the solid buying activity on VHM, KDH, VRE, HPG, DCM, and HSG. Besides, demand also spread to Industrials and Utilities thanks to large buy orders on VJC and POW. On the contrary, foreign selling activity focused on Energy and Financials sector due to large sell order on PLX, PVD, CTG, VND, and HDB.

South East Asia ETF flow

Last week, inflow has come back to SEA, net inflow was USD24mn. Particularly, the inflow was mainly driven by the solid demand on major ETFs of Vietnam. However, inflow across other major countries were not significant.

The inflow has come back across Vietnam as well as demand kept increasing. Inflow was USD27mn, tripled the previous week. Although there was the active inflow, demand focused only on Fubon ETF whilst other major ETFs such as VFMVN30 ETF, VFMVN Diamond, VNFin Lead, and KIM Growth VN30 ETF, FTSE Vietnam experienced the outflow or the insignificant flow of money. Notably, outflow spread among major ETFs whilst inflow only focused on one ETF which means the current inflow was not stable and outflow could come back if demand on Fubon ETF is paused. In this case, there is still not a good sign for the stable inflow.

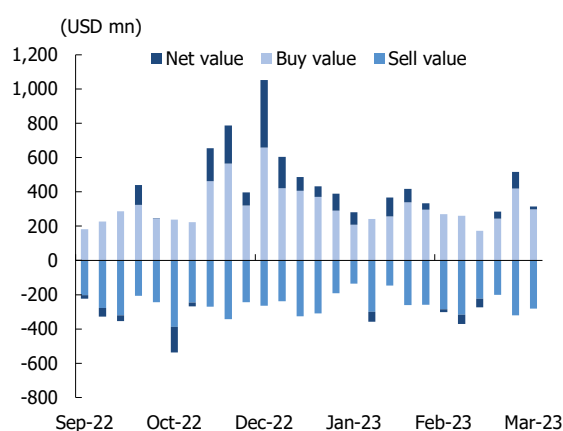

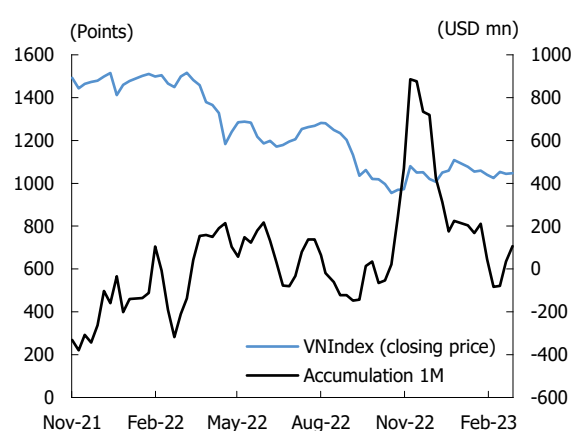

Figure 1. Weekly net foreign buy/sell



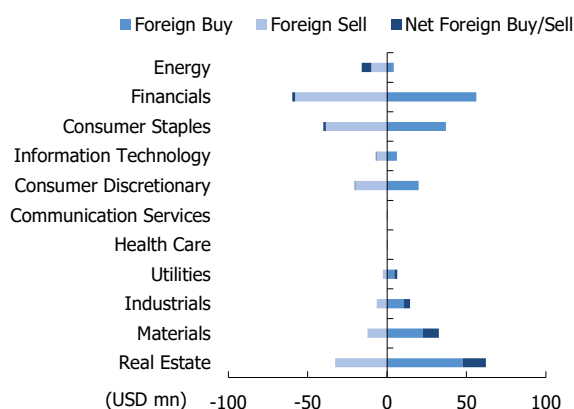

Figure 2. VNIndex and 1M accumulative foreign flow



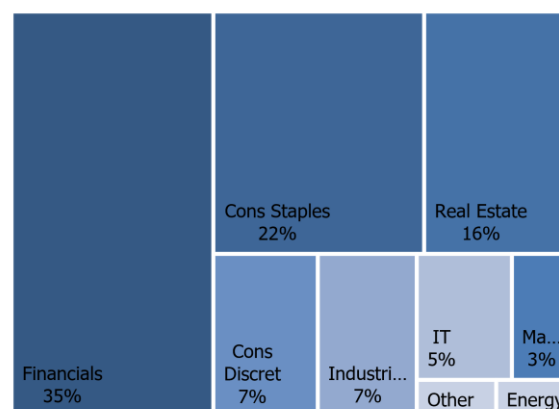

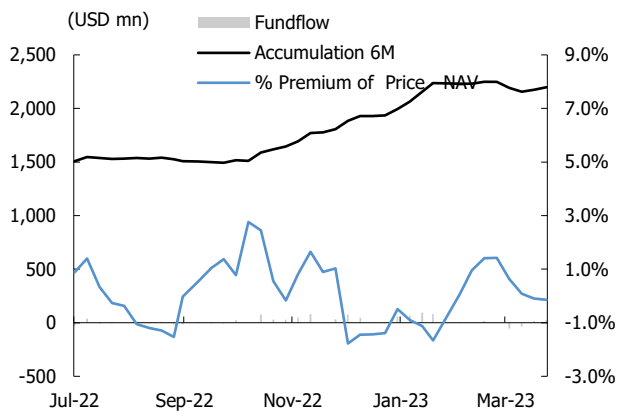

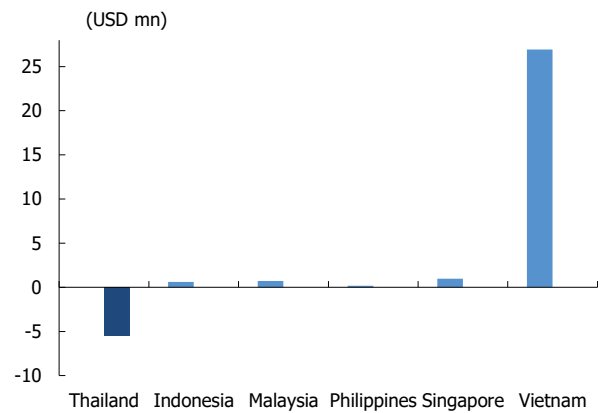

Figure 5. Weekly ETF net flow to SEA



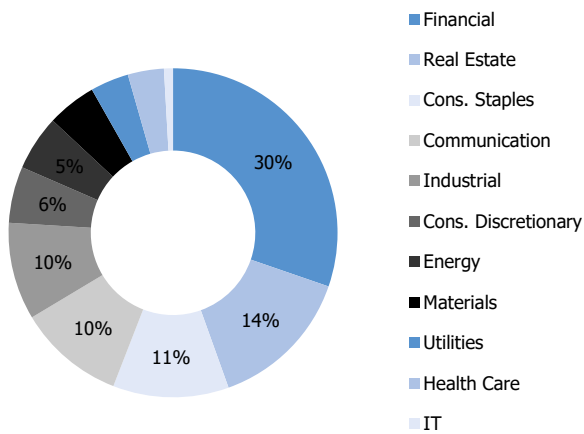

Figure 6. ETF net flow by country



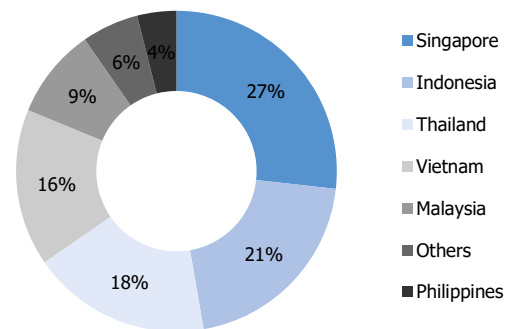

Figure 7. ETF focus by sector



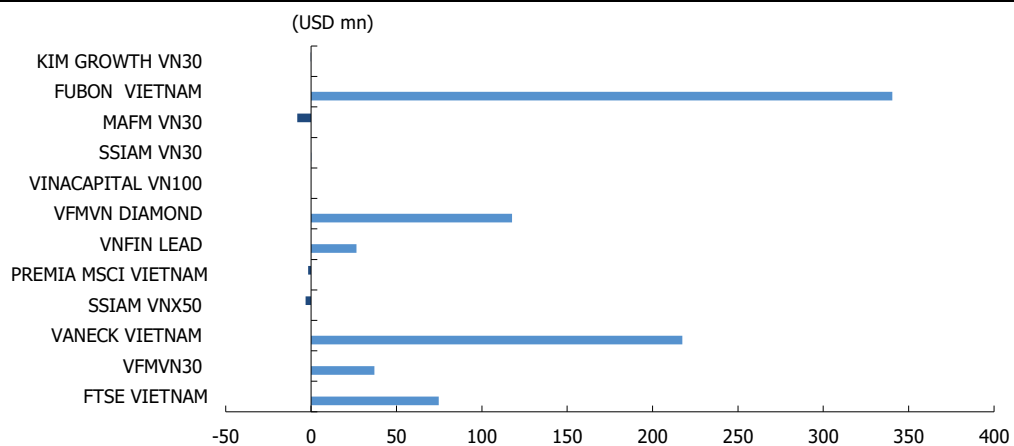
