# **Market commentary**

## Close below 1,050-pts threshold

The stock market reversed to go down yesterday due to high selling pressure in the afternoon session.

At the close, the VNIndex lost 0.57% to close at 1,048 pts. Meanwhile, trading volume was 558 million shares/VND9,713bn, down 11%/ 11% respectively, from the average of the last five sessions.

Foreign investors resumed to net sell with a net value of VND487bn on HSX. They sold MSB, BMP, and STB the most, with net values of VND400bn, VND43bn, and VND35bn, respectively.

Real Estate was the worst sector due to CEO (-2.90%), DIG (-2.30%), DXG (-2.68%), HDG (-2.19%), KBC (-3.95%), KDH (-1.90%), NLG (-2.31%), NVL (-2.02%), PDR (-1.44%), VHM (-0.79%), and VRE (-0.70%).

Banking and Energy underperformed the benchmark index, namely ACB (-1.41%), CTG (-1.37%), HDB (-1.55%), MSB (-1.59%), STB (-1.54%), TPB (-1.97%), VPB (-2.72%), GAS (-1.24%), PLX (-1.09%), POW (-2.22%), and PVS (-1.16%).

Some constituents of the VN30Index slid more than 1% such as GVR (-2.90%), BVH (-1.81%), and VNM (-1.37%).

In contrast, SAB (+2.77%), MWG (+1.38%), VJC (+1.11%), and MSN (+0.64%) closed in green territory.

The VNIndex closes below the 50-period moving average, showing a downtrend. That means the downside risk is still intact. Hence, traders should be careful and reduce long positions.
