VN30 performance

The VN30 index formed the closing price at 1,131 pts. To be specific, MWG (+3.4%), GVR (+3.2%), and NVL (+2.8%) contributed significantly to the index gains. Relating to foreign trading activity, selling pressure came back with net sell value was VND380bn, mainly driven by large buy orders on VNM, VRE, and VPB.

VN30 Future chart: 1,200 pts zone is the next destination

VN30F2307 has approached 1,120 pts zone but demand has shown no sign of weakness. Although demand has come back to the market, respecting the 1,100 pts level, but the selling pressure near 1,120 pts zone needs time to be absorbed. Short-term volatile trading period could occur. On Daily chart, the instrument is traded above major MAs, signaling the stable bullish momentum. Selling pressure is still strong near 1,120 pts zone which means the volatile period could occur. Major MAs on wider charts show the weakness of selling pressure. 1,050 pts zone is the demand zone for the rebound phase which has low probability to be broken in the short-term, followed by 1,080 pts level. Bullish momentum on wider time frames have shown no sign of weakness which means there is high probability for retesting the 1,200 pts level.

Technical strategy

Long positions on VN30F2307 should be held and stop the loss when there is the closing price below 1,085 pts level (Hourly chart).



Figure 1. VN30 Generics hourly chart





Figure 2. Basis spread





Figure 4. Open interest pattern




