VN30 performance

The VN30 index formed the closing price at 1,260 pts. Relating to foreign trading activity, supply surged with net sell value was VND600bn, mainly driven by large sell orders on HPG, SSI, and VIC.

VN30 Future chart: Bullish move

Selling pressure on VN30F2309 completely disappeared. Demand keeps increasing and the upward resumption phase is confirmed. The instrument is traded above major, signaling the active bullish swing. The 1,200 pts zone would be the strong support zone for the upward swing. Notably, four consecutive bullish candles have signaled the stable upward momentum. On wider time-frame, the bullish swing is also confirmed. However, overbought condition is currently active and new long positions are not recommended. Besides, intraday correction could take place in order to test the supply of the market. Volatility level is high.

Technical strategy

Long positions on VN30F2309 should be held and stop the loss when there is the closing price below 1,220 pts level (Hourly chart).



Figure 1. VN30 Generics hourly chart





Figure 2. Basis spread





Figure 4. Open interest pattern




