VN30 performance

The VN30 index formed the closing price at 1,235 pts. Relating to foreign trading activity, supply surged with net sell value was VND60bn, mainly driven by large sell orders on SSI, VIC, and VHM.

VN30 Future chart: Bullish move

Selling pressure on VN30F2309 has cooled down, but the upward resumption phase is active. Major MAs are flat, the selling pressure has reached the extreme and bearish swing could not extend during this trading week. The broken 1,180-1,200 pts zone has turned around to be the intraday support level or weakly support zone. Notably, MA50 is reached which means oversold condition is active and the bearish swing (correction phase) could not extend as well as reversal is not confirmed. However, MA20 is pierced which provides the solid buy point. Thus, long positions are ready.

Technical strategy

Long VN30F2309 after ATO session and stop the loss when there is the closing price below 1,200 pts level (Hourly chart).



Figure 1. VN30 Generics hourly chart







Figure 4. Open interest pattern




