#### **Corporate news**

- VPB: Deputy CEO has registered to sell 180,000 shares, reducing his holding to 649,200 shares. Transactions are made via order matching method from February 13 to March 13. (ndh.vn)
- HDB: HDB plans to sell 3.3mn treasury shares at a VND10,000/share to employees in 2020. These shares are  $\geq$ restricted from transfer within 3 years. (ndh.vn)

#### Market commentary: Consolidating within the rectangle pattern


- VN30 Index commentary: The VN30 Index dropped 1.23% to close at 852.87 pts with only 8 outperformers.  $\geq$ To be specific, ROS (+6.9%), CTD (+6.9%) and GAS (+0.9%) were index leaders. Among top 5 Index weight tickers, VNM (-1.1%), VIC (-0.6%), TCB (-1.4%), VPB (-3.0%) and HPG (0%) dragged the benchmark down. Regarding to foreign trading activities, buying activities overwhelmed, recorded a net buy value at VND56bn. Particularly, Real Estate and Materials were accumulated the most, focusing on VHM and HPG. Besides, Utilities also attracted foreign demand thanks to GAS. In contrast, this group continued to sell Consumer Staples tickers, mainly focus on VNM and MSN.
- ≻ Future's technical view: VN30F2002 gapped down on the opening bell and consolidated within the rectangle pattern yesterday. Particularly, the rectangle pattern provides the short-term support and resistance at 846 pts and 851 pts, respectively. Besides, upward momentum was lost due to the downward crossing Stochastic. In this case, traders should open positions when breakout/breakdown occurs.

Trading strategy: Long VN30F2002 at 852 pts zone, take profit at 856 pts and stoploss at 849 pts. Short VN30F2002 at 845 pts, take profit at 841 pts and stoploss at 847 pts.




