## Market commentary: Sell on pullback

- > VN30 Index commentary: The VN30 Index downed 4.55% to close at 613 pts with only 2 outperformers on the previous trading day. Particularly, VHM (-7.0%), PNJ (-6.9%), STB (-6.9%), VRE (-6.9%) and VPB (-6.9%) dragged the benchmark down. In contrast, HPG (+0.9%) outperformed the benchmark and became index leader. Regarding to foreign trading activities, selling activities ticked up, recorded a net sell value at VND41bn, focusing on MSN, STB, BID, BVH and HDB. On the contrary, VNM, HPG, VIC, VRE and POW were accumulated the most.
- Future's technical view: VN30F2004 decreased sharply on the previous trading day, following the bearish path with unclear signals for the next coming phase. Particularly, on daily time frame, MA5 was moving downward parallel with the expanding lower Bollinger band and Stochastic stayed below oversold zone for three consecutive weeks, confirming the extreme bearish market. However, on hourly time frame, the instrument consolidated during the last 3 hours of the trading day as well as price has traveled too far from MA15 and MA20, implying the potential intraday pullback. In this context, the bearish momentum remained, traders should capture short positions when pullback occurs.

Trading strategy: Short VN30F2004 at 610-615 pts zone, take profit at 580 pts and stoploss at 620 pts.




