

Limiting up

Vietnam stock markets continued to climb yesterday as an optimistic sentiment of investors. The rate of the COVID-19 spread has been slow down around the world.

At the close, the VN-Index jumped 4.98% to close at 736.7 pts. Trading volume increased to 334 million shares or VND4,649bn. The market breadth was positive, with more than five gainers against each loser, showing optimistic sentiment. Moreover, the HNX-Index increased by 5.54% to 103.2 pts.

Energy and Real Estate was the market leaders because of GAS (+6.4%), PVT (+7.0%), PVD (+6.9%), PVS (+9.7%), VIC (+6.9%), VHM (+6.9%), VRE (+6.9%), DXG (+7.0%), ROS (+7.0%), FLC (+6.7%), and TCH (+6.8%).

Meanwhile, cash flowed into banking industry driven by VCB (+3.8%), BID (+7.0%), CTG (+6.9%), HDB (+4.9%), TCB (+6.9%), ACB (+7.9%), MBB (+6.8%), STB (+6.9%), and VPB (+6.8%).

17 out of 30 constituents of the VN30-Index limited up such as BVH, CTD, HPG, MSN, MWG, PNJ, SBT, and SSI.

Foreign investors continued to sell sharply with a net value of VND670bn on HSX. VIC, VCB, and VNM were sold the most with net values of VND212bn, VND64bn, and VND61bn, respectively. On the buy side, CTG, MSN, and PHR were at the top of the list.

Technically speaking, the short-term uptrend has been confirmed as the VN-Index closes above the significant resistance at 700 pts. However, the downside risk is still intact in the medium term. Therefore, traders should increase long positions and focus on leading stocks at consolidation sessions.

Breaking news

Next meeting of the Organization of Petroleum Exporting Countries (OPEC) and its allies brings hope to the global oil market. In the last meeting of the OPEC+, the defacto leader Saudi Arabia and Russia failed to keep the agreement of cutting oil production for the first time since this coalition has been established. Since then, the global oil prices saw the biggest drop until recently. This time, some factors have changed as U.S. President Trump is playing a key role in the negotiation with Russia and Saudi Arabia. Additionally, there are also places for Kuwait, Canada, and even U.S. shale oil producers to join the pact. Also, Trump gave a hint in the last week that the total cut this time would possibly be more than 10 million barrels per day if successful. The meeting is expected to take place on Thursday, March 9th. (OPEC, Reuters, Bloomberg)

Construction steel production of HPG increases sharply. According to Hoa Phat group (HOSE: HPG), in March, construction steel production recorded at a record level of more than 351,000 tons, up 42.2% YoY. Besides, accumulated in the first quarter, Hoa Phat construction steel reached 732,000 tons, up nearly 5% YoY. (ndh.vn)


