

Vietnam Foreign Fund Flow

- Last week, foreign selling activities continued to slow down, recorded a net sell value of USD51mn, down 19.3% compared to the previous week.
- Real Estate, Consumer Staples and Financials were sold the most, recorded net sell value of USD12mn, USD11mn and USD7.4mn, respectively. Particularly, Real Estate and Consumer Staples' outflow mainly driven by VRE, VIC and MSN, fading large buy orders on NVL, LDG and PDR. With Financials, this group focused on VPB and STB. Besides, foreign demand kept decreasing across Materials, mainly driven by large sell orders on VHL and SVI.

South East Asia ETFs Flow Review *

Total ETFs 65 Total AUM (USDmn)

> Last week, South East Asia kept attracting the flow of money, recorded the net inflow at USD28mn, up 65% compared to the previous week. Specifically, Singapore was the main contributor for the flow of money. On the contrary, Malaysia continued to experience the outflow of money for seven consecutive weeks.

> Money inflow across Vietnam ticked up after five weeks outflow, recorded the net inflow at USD3mn. Of which, X FTSE Vietnam was the main driver, accounted for USD3.1mn, followed by VFMVN30 ETF with USD0.15mn inflow.








ETF Focus by Country
