## The short-term downtrend

### **VN30** performance

The VN30 Index downed 3.8% to close at 807 pts with bearish momentum spread to all tickers. Among top 5 index weight tickers, HPG (-5.6%), VPB (-4.3%), TCB (-4.3%), VIC (-2.7%) and VNM (-0.6%) dragged the benchmark down. Regarding to foreign trading activities, buying activities overwhelmed with net buy value recorded at VND181bn. Particularly, VHM, VCB, GAS, VNM and PLX were accumulated the most whilst this group focus on selling VRE, VJC, MSN, STB and POW.

### VN30 Future chart: The short-term downtrend

VN30F2006 decreased significantly yesterday, confirming the short-term downtrend. Particularly, the upward trendline was broken, Stochastic went into downward alignment, bearish momentum has taken place. However, upward crossing between MA20 and MA50 still maintained on both daily and hourly timeframe, the medium-term bearish market is not confirmed. The short-term support zone placed at 775 pts. Besides, the instrument has travelled too far from its major MAs as well as Stochastic already reached the extreme, sling shot bounce effect is likely to be occurred.

#### **Technical strategy**

In this case, traders should short this instrument when 827 pts level is retested, take profit at 775 pts and stoploss at 835 pts.



Figure 1. VN30 Generics hourly chart





Figure 2. Basis spread





Figure 4. Open interest pattern




