Based on data of 29 May, we forecast that VanEck Vectors Vietnam ETF (VNM ETF) will be added STB and not excluded Vietnam stocks in this quarterly review. We expect that STB will be bought the most with 13 million shares.

On the sell side, VRE, POW, and VCB is expected to sell heavily with a net million shares of 2.2, 1.5, and 1.1 million shares.

The results will be announced on 12 June 2020, the new weight will be effective on 22 June 2020.
