Trading signals unchanged

VN30 performance

The VN30 Index downed 0.4%, closed at 806 pts with only 12 outperformers. Particularly, REE (+2.8%), CTD (+2.3%), FPT (+1.8%), GAS (+0.8%), and CTG (+0.6%) were top 5 index leaders. In contrast, SAB (-2.9%), VRE (-2.0%), VPB (-1.3%), EIB (-1.1%), and SBT (-1.0%) were top 5 index laggards. Regarding to foreign trading activities, selling activities kept overwhelming with net sell value recorded at VND20bn. To be specific, BID, CTG, PLX, HPG, and VIC were accumulated the most whilst this group focused on selling VRE, VNM, SSI, STB, and MBB.

VN30 Future chart: Follow the bullish path

VN30F2007 broke the upward trend channel, decreasing the bullish momentum, but trading signals still support the bullish view. Notably, the upward crossover between MA50 and MA20 is confirmed, then the short-term uptrend takes place. However, as the MA20 was flat as well as Stochastic when into downward alignment, the uptrend is stalled with the decrease of upward momentum. On the upside, 815 pts zone acts as the intraday resistance level. The best way to play this pattern is waiting for the breakout at 815 pts zone to capture the long positions.

Technical strategy

Long VN30F2007 when 815 pts level is broken, take a profit at 835 pts and stop a loss immediately at 810 pts to avoid false breakout.





Figure 2. Basis spread



Figure 4. Open interest pattern




