Upward resumption phase

VN30 performance

VN30 index was added 0.9% to close at 795 pts. Among top 5 index weight tickers, HPG (+0.8%), TCB (+0.8%), VIC (+0.7%), VNM (+0.7%), and VPB (+0.2%) contributed to the index gains. Regarding to foreign trading activities, selling activities overwhelmed, net sell value recorded at VND66bn. Particularly, VHM, MSN, VRE, VJC, and NVL were sold the most whilst VNM, HPG, GAS, HDB, and POW attracted the most foreign demand across VN30.

VN30 Future chart: Only buy when price collapses

VN30F2008 pierced the 792 pts level, confirming the upward resumption phase with the respected upward trend channel. Notably, MA20 and MA50 are moving upward parallel to each other, signaling the stable trend. However, 805-810 pts zone sets the strong congestion zone where the collapse in price may occurs. Besides, the broken 792 pts level turned around to act as intraday support area. In this context, uptrend is maintained but upside objective is near. Thus, traders should hold the captured long positions as well as new long positions should be only captured when there is a sudden collapse in price.

Technical strategy

Long positions triggered at 792 pts level should not be closed, take a profit at 805 pts and stop a loss at 785 pts.



Figure 1. VN30 Generics hourly chart





Figure 2. Basis spread





Figure 4. Open interest pattern




