Hold the long

VN30 performance

VN30 index downed 0.1% to close at 792 pts. Among top 5 index weight tickers, TCB (+1.5%), HPG (+0.8%), VIC (+0.3%), and VNM (+0.3%) positively impacted the index whilst VPB (-0.5%) dragged the benchmark down. Regarding foreign trading activities, selling activities overwhelmed, net set value recorded at VND47bn. Particularly, VHM, MSN, VRE, VJC, and KDH were sold the most whilst HPG, SAB, VCB, HDB, and STB attracted the most demand across VN30.

VN30 Future chart: Long zone for the big move

VN30F2008 positively reacted with 780 pts zone, increasing the tendency for the upward resumption phase to occur. Notably, MA20 and MA50 are moving upward parallel to each other, signaling the stable trend. Besides, the instrument closed above MA5 with upward crossing Stochastic, upward momentum is improved. Additionally, 780 pts zone acts as the strong support zone for the upward resumption phase. On the upside, the breakout at 803 pts zone will increase the upside objective to 810 pts zone. As the stable bullish move, traders are recommended to hold the long positions.

Technical strategy

Long positions captured at 780 pts zone should be held, take a profit at 810 pts, and out the position at 780 pts to take the break-even point.



Figure 1. VN30 Generics hourly chart





Figure 2. Basis spread





Figure 4. Open interest pattern




