No place for the bear, focus on the long entry

VN30 performance

The VN30 Index was added 0.2% to close at 824 pts. Among top 5 index weight tickers, VNM (+1.4%), HPG (+1.0%), and VIC (+0.1%) contributed to the index gains whilst VPB (-1.1%) and TCB (-1.4%) dragged the benchmark down. Regarding to foreign trading activities, selling activities kept overwhelming, net sell value recorded at VND160bn. Particularly, VHM, VIC, VRE, VCB, and SSI were sold the most whilst PLX, CTG, VNM, HDB and BID attracted the most demand across VN30.

VN30 Future chart: The medium-term uptrend

VN30F2009 kept increasing but the upside objective is diminished. In term of congestion levels, 830-835 pts zone plays as short-term resistance zone whilst 820 pts level (MA20) is the benchmark for the intraday upward swing followed by 810-813 pts zone. As the MA20, MA50 and MA200 are moving upward, the bullish market is still active. However, upward momentum is faded due to the downward crossing Stochastic. In this case, traders should enter the bullish market when the instrument collapses.

Technical strategy

810–820 pts is identified as the significant zone for the bullish resumption. However, risk/reward ratio is unfavorable for the long at this zone. Thus, traders should be captured the long at 805-810 pts zone, take a profit at 835 pts and stop a loss at 790 pts.



Figure 1. VN30 Generics hourly chart





Figure 2. Basis spread





Figure 4. Open interest pattern




