VN30 performance

The VN30 index was added 1.6% to close at 952 pts. Among top 5 index weight tickers, HPG (+3.6%), TCB (+2.1%), VPB (+1.5%), and VIC (+1.0%) contributed to the index gains whilst VNM (0%) faded the benchmark and became index laggard. Relating to foreign trading activities, selling activities kept overwhelming with net sell value recorded at VND250bn. Particularly, MSN, HPG, and NVL were sold the most whilst VIC, VCB, and SBT attracted the most demand across VN30.

VN30 Future chart: The rebound

VN30F2011 surged yesterday, increasing the tendency to retest 950 pts area. Particularly, 930 pts area plays as the short-term resistance whilst 900 pts area acts as the line in the sand for the upward move. For intraday support zone, 915 pts is the key level. On daily time frame, the instrument positively reacted with 875 pts zone and Stochastic went into upward alignment, giving signal for the upward resumption phase. Besides, as the instrument is traded above the major MAs, upward resumption phase is confirmed.

Technical strategy

Long positions captured at 914 pts zone should not be closed, take a profit at 950 pts and out the positions at the break-even point (915 pts).



Figure 1. VN30 Generics hourly chart





Figure 2. Basis spread





Figure 4. Open interest pattern




