# Intraday collapse may occur

### **VN30** performance

The VN30 index closed at 1,181 pts. Among top 5 index weight tickers, only VPB (+0.9%) and VIC (+0.6%) positively impacted the index whilst HPG (-0.1%), TCB (-0.3%), and VNM (-0.5%) dragged the benchmark down. Relating to foreign trading activities, supply surged, with net sell value recorded at VND180bn. Particularly, VNM, HPG, and SSI were sold the most whilst VHM, VCB, and BID attracted the most demand across VN30.

## VN30 Future chart: Bullish momentum is paused

VN30F2103 lost its upward momentum at 1,200 pts, implying the maintenance of selling pressure at this zone and intraday collapse has high probability to occur. However, higher high and higher low already confirmed, implying the active upward resumption phase. The broken 1,140 pts level turns around to act as the intraday support zone. On Daily time frame, narrow spread candles occurred with high volume, signaling the increase of volatility level. Besides, narrow spread candles occurred on Hourly chart with flat MA5, bullish momentum is faded. As the instrument has unsuccessfully tested the all-time high, traders should apply "buy the dip" strategy to avoid the intraday collapse and continue to short VN30F2103 after ATO session.

#### **Technical strategy**

Short VN30F2103 after ATO session, take the profit at 1,140 pts zone and stop the loss when 1,190 pts level is pierced. Besides, place the long positions at 1,140 pts area and close all the positions if 1,120 pts level is broken.



Figure 1. VN30 Generics hourly chart





Figure 2. Basis spread





Figure 4. Open interest pattern




