# The rectangle pattern and its price objective

# **VN30 performance**

The VN30 index downed 1.3% to close at 1,167 pts. Among top 5 index weight tickers, only HPG (+0.7%) positively impacted the index whilst VNM (-1.1%), VIC (-1.6%), TCB (-1.8%), and VPB (-2.0%) dragged the benchmark down. Relating to foreign trading activities, supply surged, with net sell value recorded at VND125bn. Particularly, VNM, VHM, and SSI were sold the most whilst HPG, MBB, and GAS attracted the most demand across VN30.

# VN30 Future chart: Bullish momentum is paused

VN30F2103 confirmed the rectangle pattern breakdown with upper and lower threshold placed at 1,200 pts and 1,170 pts, respectively. The rectangle pattern provided the price objective at 1,140 pts where the strong support zone is placed. Bullish momentum is completely paused when the instrument closed below its MA20. However, the uptrend is still active due to the upward sloping MA20 and MA50 (Daily time frame). In this case, traders should apply "buy the dip" strategy to capture the low risk trade.

# **Technical strategy**

Buy VN30F2103 at 1,140 pts zone and close all the positions when there is the closing price below 1,120 pts level. (Hourly time frame)



#### Figure 1. VN30 Generics hourly chart






Figure 2. Basis spread

#### Figure 4. Open interest pattern




