Hold the long positions

VN30 performance

The VN30 index was added 1.6% to close at 1,192 pts. Among top 5 index weight tickers, TCB (+2.4%), VPB (+2.0%), HPG (+1.3%), and VNM (+0.8%) contributed to the index gains whilst VIC (-0.5%) faded the benchmark and became index laggard. Relating to foreign trading activities, supply surged, with net sell value recorded at VND210bn. Particularly, HPG, CTG, and VNM were sold the most whilst PLX, SSI, and STB attracted the most demand across VN30.

VN30 Future chart: Retest the all-time high

VN30F2103 continued to follow the upward swing after positively reacting with 1,150 pts zone, increasing the tendency to retest or even break the 1,200 pts area. Volatility level decreased thanks to the increasing bullish momentum. The uptrend is still active due to the upward sloping MA20 and MA50 (Daily time frame). In the short-term, the downward crossover between MA20 and MA50 is not confirmed, the correction is paused. However, the breakout at 1,200 pts area is not confirmed. Thus, traders should apply profit protecting strategy to decrease the downside risk.

Technical strategy

Long positions captured at 1,183.5 pts should be closed by half at 1,200 pts level. The remaining positions must be closed when there is the closing price below 1,175 pts level. (Hourly time frame)



Figure 1. VN30 Generics hourly chart





Figure 2. Basis spread





Figure 4. Open interest pattern




