The range

VN30 performance

The VN30 index was downed 1.8% to close at 1,174 pts. Among top 5 index weight tickers, only VIC (0%) outperformed the benchmark whilst TCB (-3.2%), HPG (-1.9%), VNM (-1.1%), and VPB (-0.2%) dragged the index down significantly. Relating to foreign trading activities, supply surged, with net sell value recorded at VND240bn. Particularly, VNM, VIC, and VCB were sold the most whilst PLX, MBB, and HPG attracted the most demand across VN30.

VN30 Future chart: The all-time high is still held

VN30F2103 collapsed after approaching the all-time high, implying the strong congestion zone at this area. Particularly, 1,200 pts area acts as the significant resistance zone in the short term. On the downside, 1,165 pts zone is the intraday resistance, followed by 1,140 pts area. In the short term, the instrument upside objective is decreased as well as the collapse would not last long due to the narrow Bollinger bands. On Daily time frame, the bull is still active thanks to the upward MA20, MA50, and MA200. In overall, the market is consolidating in the tight range where overnight long/short positions could not work. Thus, traders should stay on the sidelines and wait until the range is broken to capture the big swing.

Technical strategy

During the rigid price movement where trading signals are invalid, traders should stay on the sidelines and wait for the range is broken to capture the big market leg.



Figure 1. VN30 Generics hourly chart






Figure 2. Basis spread

Figure 4. Open interest pattern




