Trigger point for long positions

VN30 performance

The VN30 index was added 1.1% to close at 1,180 pts. All top 5 index weight tickers, VPB (+2.5%), VNM (+1.6%), VIC (+0.4%), TCB (+0.4%), and HPG (+0.2%) contributed significantly to the index gains. Relating to foreign trading activities, massive selling pressure came back, with net sell value recorded at VND265bn. Particularly, KDH, VCB, and HPG were sold the most whilst VIC, MBB, and NVL attracted the most demand across VN30.

VN30 Future chart: The rebound

VN30F2104 positively reacted with the important support zone (1,150 pts zone), giving signal for the rebound phase this week and the short-term downtrend is paused. Particularly, downward crossover between MA20 and MA50 is confirmed, the short-term downtrend is validated. Besides, on Daily time frame, MA20 and MA50 are flat, implying the extension of the consolidation phase. With congestion area, 1,150 pts is the key level, followed by 1,100 pts, and 1,170 pts is the intraday support level. On the upside, 1,200 pts level keep acting as the most important supply zone. Although the short-term downtrend is confirmed, there is the strong rebound and early signals for long positions.

Technical strategy

Long VN30F2104 after ATO session and add more when the instrument retests 1,175 pts zone, follow the bullish swing and out haft of the positions when 1,170 pts level is broken. If the 1,160 pts level is pierced, all long positions must be out due to the invalid buy signal.



Figure 1. VN30 Generics hourly chart





Figure 2. Basis spread





Figure 4. Open interest pattern




