Retest the important support zone the second time

VN30 performance

The VN30 index downed 2.0% to close at 1,275 pts. Among top 5 index weight tickers, only VPB (+3.9%) positively impacted the index whilst HPG (-2.3%), TCB (-2.6%), VNM (-3.5%), and VIC (-4.9%) dragged the benchmark down significantly. Relating to foreign trading activities, selling activities surged, with net sell value recorded at VND240bn. Particularly, VPB, VRE, and CTG were sold the most whilst NVL, PDR, and VHM attracted the most demand across VN30.

VN30 Future chart: The short-term correction

VN30F2105 collapsed on the previous trading day, testing the important support zone 1,250-1,260 pts the second time. Particularly, the uptrend is still active thanks to the upward sloping MA20 and MA50 (Daily chart). However, bearish momentum is strong in the short-term when the instrument closed below its major MAs (Hourly chart). With congestion zone, 1,290-1,300 pts is the short-term resistance area. As the bearish momentum is strong, the instrument is expected to drop lower on this trading day. In this case, "buy the dip" strategy is recommended.

Technical strategy

Long VN30F2105 at 1,220-1,240 pts zone and stop the loss when there is the closing price below 1,190 pts level (Hourly time frame).



Figure 1. VN30 Generics hourly chart





Figure 2. Basis spread





Figure 4. Open interest pattern




