# Forming the short-term uptrend

### **VN30** performance

The VN30 index was added 1.41% to close at 1,312 pts. Among top 5 index weight tickers, VPB (+6.4%), REE (+5.1%), HPG (+3.8%), NVL (+2.7%), and CTG (+2.6%) positively impacted the index whilst SBT (-2.2%), PDR (-1.8%), and VHM (-1.6%) faded the benchmark and became index laggards. Relating to foreign trading activities, selling activities surged, with net sell value recorded at VND440bn. Particularly, VPB, VNM, and VHM were sold the most whilst HPG, NVL, and VCB attracted the most demand across VN30.

## VN30 Future chart: Form short-term uptrend

VN30F2104 breaks out the upper line of the tight range near the short-term resistance area (1,250 pts) that implies the short-term uptrend. Besides, the long-term upward trending market has already formed thanks to the upward sloping MA50 and MA200. With congestion zone, 1,330 is the short-term resistance area whilst 1,280 pts zone is the important support.

### **Technical strategy**

Buy VN30F2104 if it has opening price higher 1,300-pts threshold and stop the loss when 1,280 pts level is pierced.



Figure 1. VN30 Generics hourly chart





Figure 2. Basis spread





Figure 4. Open interest pattern




