

Bullish momentum surges

VN30 performance

The VN30 index was added 2.2% to close at 1,371 pts. All top 5 index weight tickers, VNM (+6.9%), HPG (+3.6%), TCB (+2.2%), VPB (+1.3%), and VIC (+0.4%) contributed significantly to the index gains. Relating to foreign trading activities, selling activities overwhelmed, with net sell value recorded at VND51bn. Particularly, CTG, VCB, and KDH were sold the most whilst VHM, HPG, and VRE attracted the most demand across VN30.

VN30 Future chart: The extension phase

VN30F2105 surged on the previous trading day, increasing the tendency to retest 1,400 pts area. The uptrend is active with strong bullish momentum thanks to the upward sloping major MAs (MA20 and MA50). Besides, the upward swing duration will be longer due to the extension Bollinger bands. However, the instrument has travelled far from its major MAs, giving the first sign for the intraday collapse. 1,280 pts area is the short-term support zone whilst 1,320 pts area is the intraday demand zone. Notably, there is no signal for the downtrend. Thus, traders should hold the long positions.

Technical strategy

Long positions captured at 1,280-1,300 pts area and 1,300-1,320 pts area (on Friday session) should be held and close the positions only when there is the closing price below 1,320 pts level (Hourly time frame).

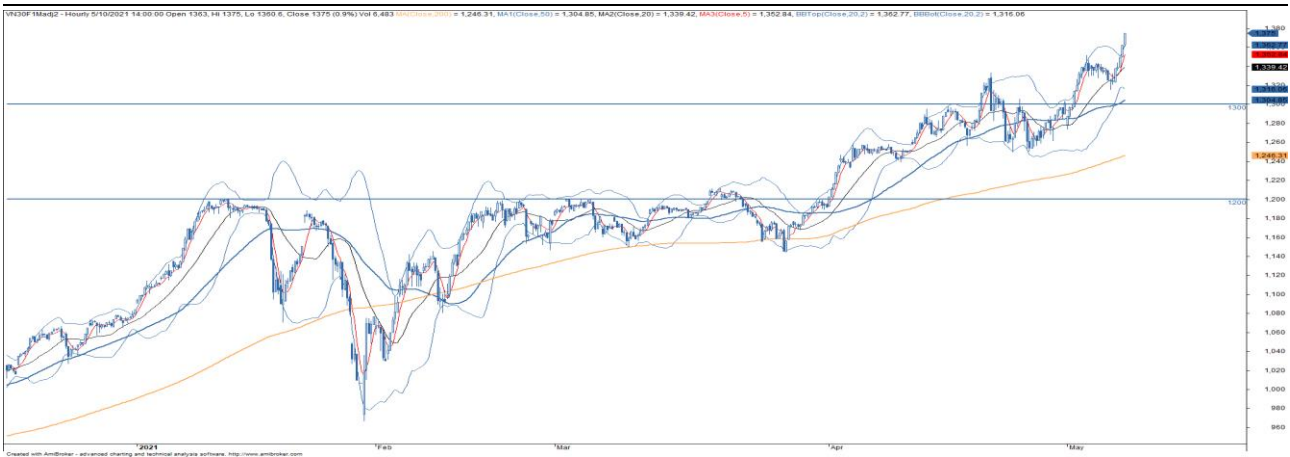

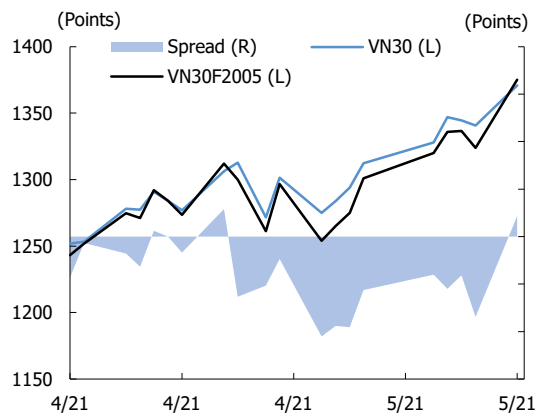

Figure 1. VN30 Generics hourly chart



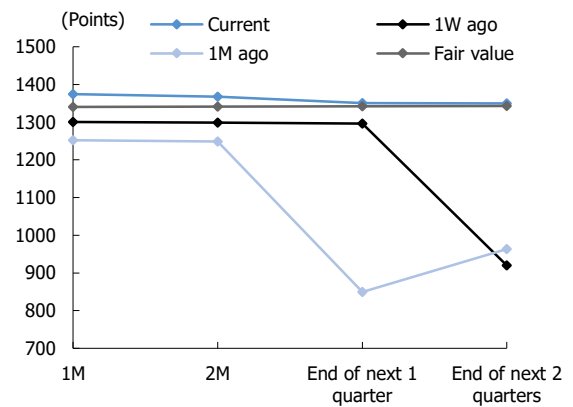

Figure 2. Basis spread



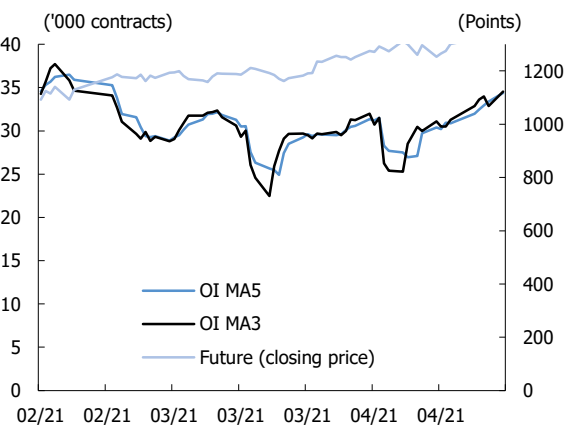

Figure 3. Future price curve



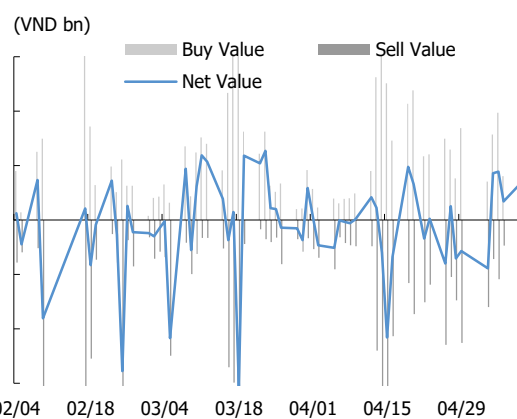
