"Buy the dip"

VN30 performance

The VN30 index downed 0.8% to close at 1,359 pts. Among top 5 index weight tickers, only VPB (+1.1%) positively impacted the benchmark whilst VIC (-1.1%), HPG (-1.6%), VNM (-1.9%), and TCB (-2.3%) dragged the index down. Relating to foreign trading activities, selling activities overwhelmed, with net sell value recorded at VND290bn. Particularly, HPG, NVL, and VIC were sold the most whilst VPB, STB, and VHM attracted the most demand across VN30.

VN30 Future chart: Intraday correction phase

VN30F2105 has lost its bullish momentum, forming the short-term resistance at 1,380-1,400 pts zone. The uptrend is active with strong bullish momentum thanks to the upward sloping major MAs (MA20 and MA50). However, the instrument is testing its short-term trend benchmark - MA20 as well as this MA is still respected. Thus, bearish momentum is not strong. 1,280 pts area is the short-term support zone whilst 1,320 pts area is the intraday demand zone. Notably, there is no signal for the downtrend. Thus, traders should hold the long positions and apply "buy the dip" strategy when the intraday collapse extends.

Technical strategy

Long positions captured at 1,280-1,300 pts area and 1,300-1,320 pts area (on Friday session) should be held and close the positions only when there is the closing price below 1,320 pts level (Hourly time frame). For new positions, traders should buy VN30F2105 at 1,330-1,340 pts zone and stop the loss when there is the closing price below 1,320 pts level (Hourly time frame).



Figure 1. VN30 Generics hourly chart





Figure 2. Basis spread





Figure 4. Open interest pattern




