VN30 performance

The VN30 index added 1.5% to close at 1,380 pts. Among top 5 index weight tickers, only VIC (-0.9%) negatively impacted the index whilst TCB (+4.8%), VPB (+1.6%), HPG (+1.1%), and VNM (+0.7%) contributed significantly to the benchmark gains. Relating to foreign trading activities, selling activities overwhelmed, with net sell value recorded at VND520bn. Particularly, HPG, NVL, and VIC were sold the most whilst VPB, STB, and BVH attracted the most demand across VN30.

VN30 Future chart: Bullish momentum comes back

VN30F2105 has gained back its bullish momentum, increasing the tendency to test the 1,400 pts area. The uptrend is active with strong bullish momentum thanks to the upward sloping major MAs (MA20 and MA50). Besides, as the Bollinger bands are expanding, the upside objective is increased. With congestion zone, 1,320 pts area is the short-term demand zone whilst 1,340 pts area acts as the intraday support zone. The uptrend is active, but the correction could occur at 1,400 pts area. Thus, traders should focus on protecting the open profit as well as open new position is not recommended.

Technical strategy

Long positions captured at 1,280-1,340 pts area should be closed by half after ATO session, the remaining positions should be closed when there is the closing price below 1,340 pts level (Hourly chart).



Figure 1. VN30 Generics hourly chart





Figure 2. Basis spread





Figure 4. Open interest pattern




