Tightening phase steps in

VN30 performance

The VN30 index downed 1.2% to close at 1,437 pts. All top 5 index weight tickers, VPB (-0.3%), VNM (-0.5%), VIC (-1.2%), HPG (-1.5%), and TCB (-2.7%) dragged the benchmark down significantly. Relating to foreign trading activities, buying activities outperformed the selling pressure, with net buy value recorded at VND8bn. Particularly, HPG, VPB, and TPB were sold the most whilst PLX, VNM, and VCB attracted the most demand across VN30.

VN30 Future chart: The short-term tightening phase

VN30F2105 decreased strongly after negatively reacting with 1,450-1,460 pts area, forming the short-term resistance at this zone. However, we are still in the good uptrend thanks to the upward sloping major MAs. With congestion zone, 1,370 pts area is the short-term demand zone whilst 1,410 pts area keep acting as the intraday support zone. In the short term, the instrument is in the tightening phase as well as re-enter point is not occur. Thus, traders should stay on the sidelides and buy only when there is the accurate trigger point.





Figure 1. VN30 Generics hourly chart





Figure 2. Basis spread





Figure 4. Open interest pattern




