Bullish momentum surges

VN30 performance

The VN30 index was added 1.1% to close at 1,475 pts. Among top 5 index weight tickers, only HPG (+6.8%), TCB (+1.3%), and VPB (+0.9%) positively impacted the index whilst VNM (-0.7%) and VIC (-1.9%) faded the benchmark and became index laggard. Relating to foreign trading activities, selling activities skyrocketed, with net sell value recorded at VND1,500bn. Particularly, HPG, MBB, and VCB were sold the most whilst PLX, NVL, and KDH attracted the most demand across VN30.

VN30 Future chart: Heading to 1,500 pts zone

VN30F2106 kept heading to the higher zone, confirming the breakout at 1,450 pts area and increasing the tendency to test 1,500 pts level. Particularly, the uptrend is expected to continue to extend thanks to the upward sloping major MAs. Besides, volume has started to tick up, implying the increase of buying activities at this zone. In this case, holding the captured long positions is highly recommended.

Technical strategy

The captured long positions (VN30F2106) at 1,450-1,460 pts area should not be closed and stop the loss when there is the closing price below 1,435 pts.





Figure 1. VN30 Generics hourly chart





Figure 2. Basis spread





Figure 4. Open interest pattern




