Volatility level starts to surge

VN30 performance

The VN30 index gained 0.5% to close at 1,483 pts. Among top 5 index weight tickers, only HPG (+5.3%), VIC (+2.1%), and VPB (+0.1%) contributed to the index gains whilst VNM (-0.7%) and TCB (-1.1%) faded the benchmark and became index laggards. Relating to foreign trading activities, selling activities maintained at high level, with net sell value recorded at VND600bn. Particularly, HPG, STB, and VCB were sold the most whilst TPB, VHM, and VRE attracted the most demand across VN30.

VN30 Future chart: Uncertainty at 1,500 pts area

VN30F2106 kept heading to the higher zone, but the bullish momentum has started to pause while approaching 1,500 pts area. The broken area (1,450 pts zone) turned around to act as the weekly support whilst 1,500 pts level set the supply zone for the instrument. Uptrend is active thanks to upward sloping major MAs. However, there is the narrow spread candle on Daily chart, implying the increase of volatility level. Notably, the surge of volatility level is often the first sign for the intraday collapse. In this case, traders should reduce the current long positions after ATO session.

Technical strategy

The captured long positions (VN30F2106) at 1,450-1,460 pts area should be closed by half after ATO session and out all the positions when there is the closing price below 1,450 pts.



Figure 1. VN30 Generics hourly chart





Figure 2. Basis spread





Figure 4. Open interest pattern




