1,500 pts zone is reached

VN30 performance

The VN30 index gained 1.7% to close at 1,504 pts. All top 5 index weight tickers, TCB (+3.8%), VIC (+0.9%), VNM (+0.9%), HPG (+0.6%), and VPB (+0.6%) contributed significantly to the index gains. Relating to foreign trading activities, selling activities maintained at high level, with net sell value recorded at VND1,000bn. Particularly, HPG, VIC, and MBB were sold the most whilst SSI, NVL, and PLX attracted the most demand across VN30.

VN30 Future chart: Stable bullish momentum at 1,500 pts

VN30F2106 tested the 1,500 pts level after the occurrence of valid breakout. The broken area (1,450 pts zone) turned around to act as the weekly support whilst 1,500 pts level set the supply zone for the instrument. Uptrend is active thanks to upward sloping major MAs. Besides, there is no signal for the decrease of bullish momentum at 1,500 pts zone. In this case, traders should hold the current long positions and follow the exit plan.

Technical strategy

The captured long positions (VN30F2106) at 1,450-1,460 pts area and 1,490 pts zone should be closed only when there is the closing price below 1,480 pts.



Figure 1. VN30 Generics hourly chart





Figure 2. Basis spread





Figure 4. Open interest pattern




