

Hold the long positions

VN30 performance

The VN30 index closed at 1,489 pts. Among top 5 index weight tickers, VPB (+4.5%) and TCB (+0.4%) positively impacted the index whilst VIC (-0.5%), HPG (-0.6%), and VNM (-0.7%) faded the benchmark and became index laggards. Relating to foreign trading activities, buying activities surged, with net buy value recorded at VND125bn. Particularly, VPB, VRE, and SSI were sold the most whilst VHM, VCB, and STB attracted the most demand across VN30.

VN30 Future chart: Bullish momentum maintains

VN30F2107 has maintained its bullish momentum despite the increase of volatility level. The solid intraday support at 1,475 pts zone is formed. 1,400 pts area keeps acting as the strong support zone whilst 1,500 pts zone plays as the intraday supply zone. Narrow spread candles occurred on Daily chart, implying the surge of volatility level. However, the bullish view is confirmed when this instrument closed above major MAs at the end of the trading day. In this case, traders could enter the long positions with the tight stop loss level on this trading day.

Technical strategy

Keep buying VN30F2107 after ATO session and stop the loss only when there is the closing price below 1,475 pts level. (Hourly time frame)

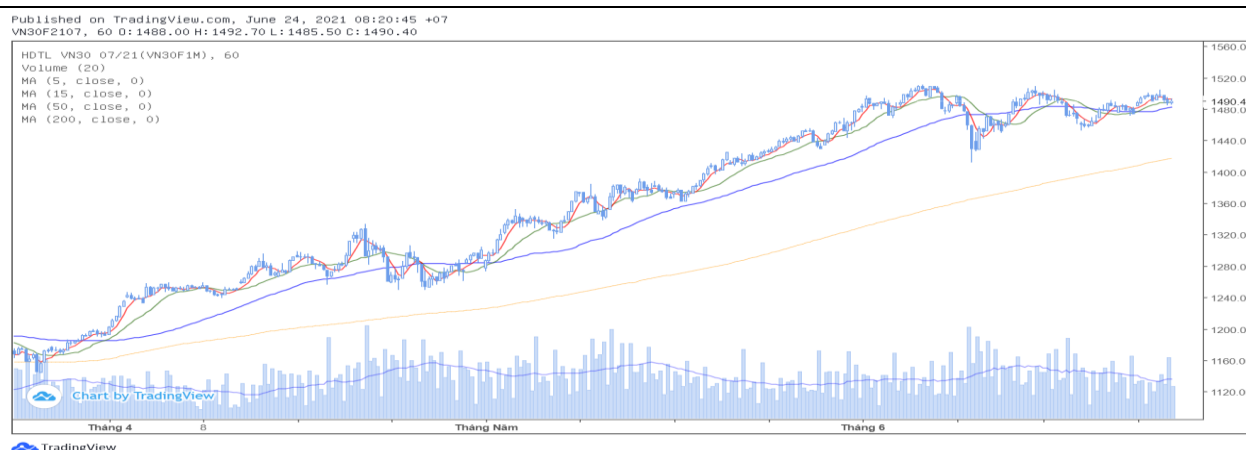

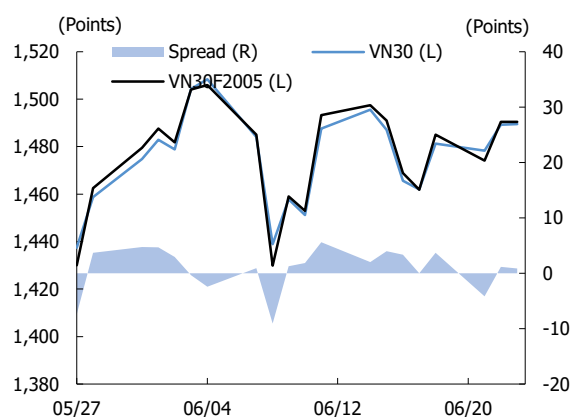

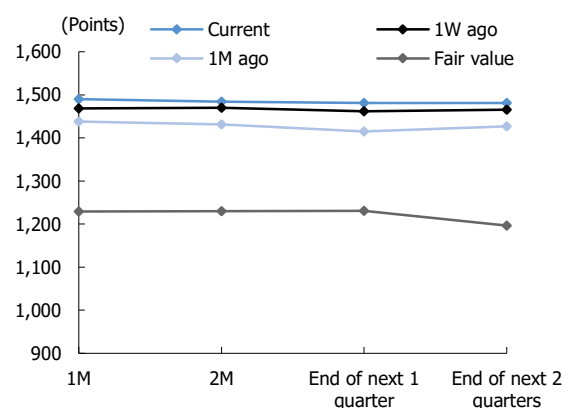

Figure 1. VN30 Generics hourly chart

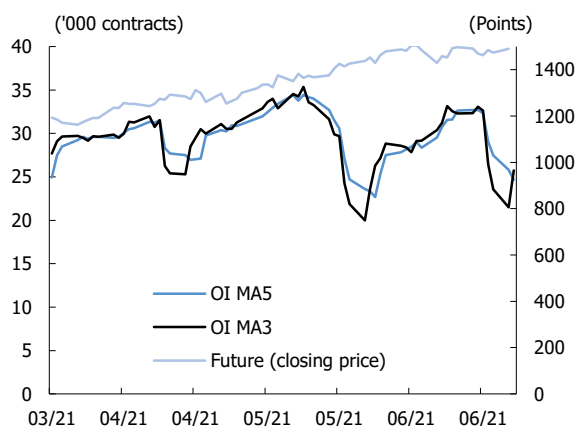

Figure 2. Basis spread

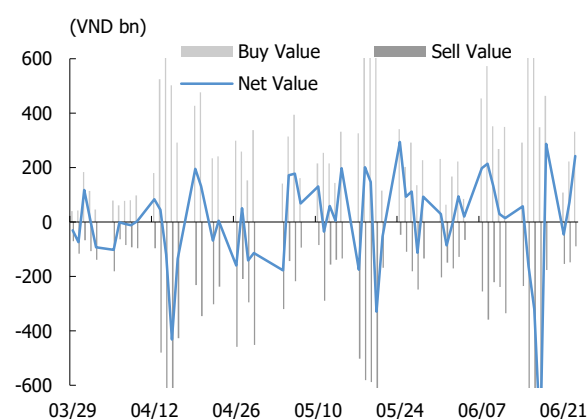
