The pullback

VN30 performance

The VN30 closed at 1,529 pts. Among top 5 index weight tickers, VPB (+1.2%) and VIC (+0.8%) positively impacted the benchmark whilst HPG (-0.6%), VNM (-0.7%), and TCB (-1.5%) dragged the index down. Relating to foreign trading activities, buying activities surged, with net buy value recorded at VND1,600bn. Particularly, VPB, MBB, and VRE were sold the most whilst VHM, VCB, and NVL attracted the most demand across VN30.

VN30 Future chart: The pullback

Bullish momentum has started to halt on VN30F2107, giving the first signal for the pullback where re-entry point will be formed. With congestion zone, 1,480 pts area keeps acting as the strong support zone whilst 1,550 pts zone plays as the intrady supply zone. For intraday trading, 1,510 pts zone is the major demand zone. Notably, subsequent bearish candles occurred, increasing the tendency for the intraday correction. However, the uptrend is active. Thus, traders should buy when there is the intraday collapse.

Technical strategy

All recommended long positions on VN30F2107 should be held and stop the loss only when there is the closing price below 1,480 pts level (Hourly time frame). For new buy point, buy VN30F2107 at 1,510 pts area and stop the loss when there is the closing price below 1,480 pts level (Hourly time frame).



Figure 1. VN30 Generics hourly chart





Figure 2. Basis spread





Figure 4. Open interest pattern




