VN30 performance

The VN30 index gained 0.5%, forming the closing price at 1,453 pts. Relating to foreign trading activities, demand ticked up with net buy value recorded at VND70bn. Notably, foreign demand focused on MBB, VCB, and VNM.

VN30F2110 followed the tight movement as well as there is no valid signal for the upcoming market leg. Notably, the instrument closed below major MAs, the bullish momentum is completely faded. Besides, major MAs are flat as well as Bollinger bands are narrowing (Daily chart), the next market move is unclear. In this case, traders should stay on the sidelines and wait for more accurate signal.

Technical strategy

The instrument is traded in the tight zone where price noise will fade al trading signals. In this case, traders should stay on the sidelines and wait for more accurate signal.





Figure 2. Basis spread



Figure 4. Open interest pattern




