Short-term correction phase

VN30 performance

The VN30 index formed the closing price at 1,489 pts. Relating to foreign trading activities, selling activities kept overwhelming with net sell value recorded at VND1,160bn. Notably, foreign selling pressure focused on HPG, VIC, and VHM.

VN30 Future chart: Short-term correction phase

VN30F2111 dropped on the previous trading day, breaking the trading zone and confirming the short-term correction phase. With congestion zone, 1,520 pts zone set the strong supply zone whilst 1,450 pts area is the significant demand zone. However, the uptrend is still active thanks to the upward crossover between major MAs. In this case, traders should wait for the buy point which would occur after the correction phase.

Technical strategy

Although there was the wide bearish swing, uptrend is still maintained. Thus, traders should wait for the buy point which would occur after the correction phase.





Figure 1. VN30 Generics hourly chart





Figure 2. Basis spread





Figure 4. Open interest pattern




